# GOOGLE PIXEL SUPERFAN SWEEPSTAKES OFFICIAL RULES

#### 1. ELIGIBILITY:

To be eligible to enter the Sweepstakes you must be a legal United States resident residing in the forty-eight (48) United States (excluding Hawaii and Alaska) or District of Columbia, and at least eighteen (18) years of age and the age of majority in your state of residence as of date of entry. #### 3. HOW TO ENTER:

# ENTRY PERIOD & GRAND PRIZE ENTRIES: To earn one (1) entry into an Entry Period Drawing and automatically receive one (1) entry into the Grand Prize Drawing:

The Entry Period Prizes, Bonus Prizes, and the Grand Prize are collectively referred to as "Prize(s)."

Entry Limits: Limit one (1) Entry Period entry and one (1) Grand Prize entry per person/authorized email account holder per Entry Period. Limit fourteen (14) Entry Period entries and fourteen (14) Grand Prize entries per person/authorized email account holder during the Sweepstakes Period. - Round-trip economy class air transportation for winner and one (1) guest from a major commercial airport near winner's residence (selected at the sole discretion of Sponsor) to a major commercial airport near the Championship Game venue.
- \$2,600 gross up payment in the form of a corporate check awarded to the Grand Prize winner to assist with tax obligations, and incidentals during the Prize trip such as at the hotel, food, ground transportation, or spending cash.

The ARV of the Grand Prize is \$8,975.99.

The ARV of each Entry Period First Prize is \$449.99.
- Entry Period Second Prize: One (1) Team Pixel autographed NWSL jersey and one (1) pair of Pixel Buds Pro 2 (Jersey signature(s), design, color, size, display, and all other aspects of the jersey are at the sole discretion of the Sponsor. Earbuds color, and all other aspects of the earbuds are at the sole discretion of the Sponsor.) The ARV of each Entry Period Second Prize is \$379.

<u>Fourteen (14) Bonus Prizes</u>: One (1) Bonus Prize is available only to eligible entrants (see *Bonus Prize Entry* in Section 3 above) during each of the fourteen (14) Entry Periods.

Entrants are advised to add info@GMRpromotions.com to their safe senders list to ensure any email notification is delivered to their inbox The potential Grand Prize winner will have forty-eight (48) hours from the time of the first notification to respond to the email and/or phone call and provide their responses to the presented eligibility questions or the potential Grand Prize winner will automatically forfeit the Grand Prize in its entirety.

The potential Grand Prize winner will be required to complete, sign, have notarized and return the presented affidavit of eligibility, liability waiver and publicity release, a background investigation authorization form, and the appropriate tax documents (the "Documents") via the secure electronic notary process provided by GMR or other method acceptable to the Sponsor, within **five (5) calendar days** of delivery of the Documents, and may need to pass a background check prior to being confirmed as the Grand Prize winner, or the Grand Prize will be forfeited in its entirety.
